Pursuant to Article 4 of the Decision Establishing the National Trade Facilitation Body (*Official Gazette of the Republic of Serbia*, No. 98/17) and Article 12 of the Rules of Procedure of the National Trade Facilitation Body, at its meeting held on 11 May 2018, the National Trade Facilitation Body hereby enacts this

DECISION ESTABLISHING EXPERT GROUPS OF THE NATIONAL TRADE FACILITATION BODY

1. This Decision establishes the following standing Expert Groups of the National Trade Facilitation Body:

I. Expert Group on Agriculture and Sanitary and Phytosanitary Measures

[1] The Expert Group on Agriculture and Sanitary and Phytosanitary Measures shall be tasked with considering issues and proposing initiatives designed to promote and facilitate foreign trade in agricultural produce and food products. In doing so, shall ensure that any veterinary, sanitary, and phytosanitary measures are introduced and applied with regard to foreign trade in agricultural produce and food products so as to avoid unduly burdening businesses while ensuring appropriate protection of human, plant, and animal health, as well as that technical regulations, standards, and conformity assessment procedures are enacted and implemented without constituting unnecessary obstacles to trade in these products.

[3] The Expert Group on Agriculture and Sanitary and Phytosanitary Measures shall be chaired by the representative of the Ministry of Agriculture, Forestry and Water Management.

II. Expert Group on Technical Barriers to Trade and Equivalent Measures

[1] The Expert Group on Technical Barriers to Trade and Equivalent Measures shall be charged with considering issues and proposing initiatives designed to promote and facilitate foreign trade in industrial (non-food) products (which include cosmetics, other consumer goods, medicines, medical devices, chemicals, machinery and various types of technical equipment, and the like). In doing so, shall ensure that technical regulations, standards, and conformity assessment procedures are enacted and implemented without constituting unnecessary obstacles to trade.

[3] The Expert Group on Technical Barriers to Trade and Equivalent Measures shall be chaired by the representative of the Ministry of Economy.

III. Expert Group on Customs Procedures

[1] The Expert Group on Customs Procedures shall be responsible for considering issues and proposing initiatives designed to enhance and facilitate customs procedures; broader application of simplified customs procedures for imports, exports, and transit of goods; and greater consistency and predictability of actions taken by customs bodies.

[1] The Expert Group on Coordination of Trade Facilitation Activities under International and Regional Trade Agreements shall provide support to structures envisaged by these agreements for coordination and prioritization of trade facilitation activities at the national level. It shall also promote compliance with best global and regional practices and aim to reduce costs incurred by the private sector due to inefficient procedures.

2. Expert Groups shall be required to produce and enact annual action plans for 2018 for areas from their competence and notify the National Trade Facilitation Body thereof.
