### **ANNUAL REPORT FOR 2019**

Belgrade, March 2020

#### 1. INTRODUCTION

The National Coordination Body for Trade Facilitation (hereinafter: NTFB) was established by the Decision of the Government of the Republic of Serbia<sup>1</sup> in November 2017. This body was established to ensure comprehensive and effective facilitation of foreign trade of the Republic of Serbia and to coordinate efforts by the competent authorities, organisations, business community and other participants in the foreign trade system.

Stevan Nikčervić, the State Secretary in the Ministry of Trade, Tourism and Telecommunications is the **Chairman of the National Coordination Body**. At the proposal that the Customs Administration put forward in February this year, current **Vice-Chair**, Veselin Milošević will be replaced by Dušan Marinković, Acting Assistant Director – Coordinator of the Customs Administration in the Ministry of Finance.

Expert and administrative and technical support to the National Coordination Body is provided by the Ministry of Trade, Tourism and Telecommunications in cooperation with the Customs Administration.

The National Coordination Body submits to the Government regular annual reports on their work by March 31 of the current year at the latest for the previous year and, whenever necessary, the extraordinary reports. Based on this obligation, the Report for 2018 was delivered to the Government for information purposes on March 22, 2019 under number 337-00-00061/2018-10; the Report covered the period from March 2018 to March 2019.

In the said document, the following activities were planned to be carried out during the reporting period: efforts aimed at fulfilling the obligations laid down in Action Plans for 2018 and 2019; drawing up of new Action Plans for 2020 and 2021, as well as fulfilling of obligations arising from the implementation of CEFTA Additional Protocol 5. It can be concluded that practically all the objectives set have been fulfilled to a substantial degree, as presented in detail in this Report, which covers the activities realized from March 2019 until March 2020.

Progress achieved in Serbia based on the activities realized within the NTFB was recognized by the international organisations as well. Thus, according to the assessment from the **Third UN Global Survey on Digital and Sustainable Trade Facilitation for 2019,** the trade facilitation measures in Serbia were fulfilled to 61.29%, which is a significant positive achievement compared to the previous reports according to which this assessment was significantly lower (the result for 2015 was 36.56%, and the result for 2017 was 38.71%). The Global Survey is published biannually and it includes the survey of 128 economies throughout the world that comprises of an analysis of the implementation of 53 measures relating to the implementation of the World Trade Organisation (WTO) Trade Facilitation Agreement. Serbian progress has been recognized in the **World Bank Tracking Tool,** which tracks and monitors the implementation of the WTO Trade Facilitation Agreement for individual countries, where Serbian alignment in 2018 rose to 78% compared to 65% in 2014.

### 2. REPORT ON ACTIVITIES IMPLEMENTED BY NTFB EXPERT WORKING GROUPS

In accordance with Article 4 of the Decision on Establishing the National Coordination Body, four expert working groups were formed to carry out the NTFB activities. The expert working groups consider individual issues and participate in proposing solutions with the aim of facilitating foreign trade, removing barriers to trade, streamlining and modernizing customs procedures and carrying out of import, export and transit controls, simplifying processes and reducing formalities, with active participation and presence of interested members from the business community, Chambers and other Associations, other holders of public powers, representatives of scientific and educational institutions, as well as other organisations capable of impacting facilitation of foreign trade.

In January 2020, the NTFB adopted a new Decision on Establishing Expert Working Groups, based on the previously adopted amendment to the Decision on Establishing the NTFB. In the Decision dated January 15, 2020, the list of members of all the Expert Working Groups was consolidated, to include the latest changes both among the public authorities, and from the private sector, with the inclusion of representatives of the National Alliance for Local Development (NALED) among the members of the first Expert Working Group.

## 2.1. Report on completed activities of the Expert Working Groups relating to fulfilment of obligations contained in the Action Plans for 2018 and 2019

### I – EXPERT WORKING GROUP FOR AGRICULTURE, SANITARY AND PHYTOSANITARY MEASURES

**Chairperson: Milanka Davidović**, Department Head, from the Ministry of Agriculture, Forestry and Water Management

1. Activities undertaken to reduce the time required to complete the import procedures and to establish an efficient risk analysis system according to the Action Plan are interrelated. Intensive efforts were made to analyse all aspects impacting operations of competent inspections during border controls and the duration of these controls.

Experiences and views were exchanged among competent services and representatives of the business community. Focus was on the goods with shorter expiration dates, the so-called perishable goods, primarily on fruits and vegetable.

Work of inspection services on the border crossing Preševo has been improved – through introduction of 24/7 working hours, and an initiative was addressed to the Government relating to other border crossings, primarily to Horgoš, concerning introduction of working hours of 24 hours a day.

At the initiative and with the assistance from the business community (AmCham), a French expert was hired to perform an analysis of the entire border crossings' control system for shipments of agricultural and food products and to prepare a proposal for improvements, i.e. establishing of an efficient risk analysis system by all the inspection services. In May 2019, the hired expert presented the report and proposed a risk analysis model adjusted to the conditions in our country. This model was presented to the competent services and the representatives of the Plant Protection Directorate of the Ministry of Agriculture, Forestry and Water Management agreed on further development of that model, as well as on the inclusion of all the products within their competence in addition to fruit and vegetables. The business community contacted donors to enable further operationalization of the proposed model through its inclusion in the Plan of Official Import Controls, and then through the information system that is to be developed (in the first phase, food of plant and mixed origin, animal feed of plant origin, with an

emphasis on perishable goods). Time limits and obligations were defined both for the competent authorities and for the representatives of the USAID, AmCham, the World Bank. Efforts are currently made to fulfil the necessary preconditions, develop a single information system (bearing in mind the activities related to E-inspector and ITCM project as well).

All of the above mentioned should lead to establishing of a modern risk analysis model, which shall rank the shipments based on various parameters and/or based on the combination of risks, from the product type to the country of origin, producer, destination and importer.

- 2. **Alignment of competences of individual inspection authorities** has been achieved through the amendments to the following legal regulations:
- Law on Amendments to the Law on Food Safety, in March 2019 legal basis has been provided for more specific defining of competencies of the relevant inspections;
- Rulebook on the Type of Food and Method for Conducting Official Controls and on the Lists of Mixed Food and Method for Conducting Controls of Such Food April 2019 (defining of the competencies of inspections in more detail);
- Rulebook on Conditions for Shipments not Requiring Veterinary-sanitary Decisions for Import and/or Transit June 2019 (expanded list of products not requiring decisions on veterinary and sanitary conditions for import and/or transit thereof);
- Rulebook on Determining the Monitoring Program for Safety of Imported Food of Animal Origin and Animal Feed for 2019 June 2019;
- Plan of Official Controls for Imports of Food of Plant Origin, Mixed Food, Animal Feed of Plant Origin in 2019.
- 3. **Upgrading capacities of inspection services** is also among the necessary preconditions for the improvement of work and removal of administrative barriers.

A job competition is currently underway to fill the vacancies in all the three inspections (veterinary, phytosanitary and agricultural).

According to the Action Plan, an increase in the number of employees in 2020 and in 2021, which was adopted by the Government in 2019, has been planned with a view to improve the work of all the inspections. The number of employees will be increased in all the inspection services competent to carry out controls of agricultural and food products.

4. With the aim to improve the conditions for product marketing and to remove trade barriers in **2019**, several agreements have been concluded: with the UAE on veterinary cooperation; with China on import and export of foodstuff and food safety, dairy products and pig meat; with North Macedonia on phytosanitary cooperation, food safety and veterinary matters; with the Russian Federation in the field of plant quarantine and plant protection.

An initiative has been launched to conclude an agreement with Albania.

## II – EXPERT WORKING GROUP ON TECHNICAL BARRIERS TO TRADE AND EQUAL MEASURES

**Chairperson: Zoran Bakić,** Group Head, Ministry of Economy, Sector for Product Quality and Product Safety

- 1. Concerning the part of Action Plan activities relating to establishing an efficient risk analysis system, significant new developments have been achieved in the previous period, primarily by the market monitoring authority of the Ministry of Trade, Telecommunications and Tourism, and by the Customs Administration of the Ministry of Finance. On the other hand, it has been established that the acquiring of documents for importation of certain industrial non-food products is still mandatory, which is an obligation that has been assessed to present a barrier to trade and which has been applied based on the Decision on determining the goods for the import, export and/or transit of which acquiring of certain documents was prescribed. These restrictions present unnecessary obstacles and shall be included in the Action Plan for this Expert Working Group for the following period.
- 2. In the process of **harmonisation of domestic regulations with the EU acquis,** the Law on Construction Products has been passed, whereby the Regulation (EU) No 305/2011 of the European Parliament and of the Council of 9 March 2011 laying down harmonised conditions for marketing of construction products has been transposed, along with a number of by-laws (technical regulations). Additionally, the Law on Products of General Use and the Rulebook on Toy Safety were adopted. The only segment in which no progress has been made is the field of radio equipment, in which it is necessary to transpose the Radio Equipment Directive 2014/53/EU (RED) from 2014.
- 3. With regard to the reduction of delays in registration issuing for **new medicines** and registration renewal, almost no progress has been achieved. It is also necessary to point out to the low level of cooperation achieved with the competent institution in this field.
- 4. Further streamlining of procedures for acceptance of foreign certificates on conformity issued by the notified conformity assessment bodies (EU NANDO database) and EA MLA signatories, has led to signing of a concrete Memorandum of Understanding on Mutual Cooperation and Acceptance of Documents Issued by the Laboratories Accredited for Industrial Non-food Products with Bosnia and Herzegovina. The same Memorandum text was offered to the Republic of North Macedonia; that party, however, has not showed any interest in it. In addition to that, through their everyday activities, the Ministry of Economy and its **Sector for Product Quality and Safety are promoting possible benefits resulting from signing of the EA Multilateral Agreement** between the national accreditation body and the European Accreditation, along with the solutions from the Decree on the Manner of Recognition of Foreign Documents of Conformity and Conformity Marks (from 2016) whereby the objective from the fourth point of the Action Plan for this Expert Working Group has been achieved to its current maximum.

#### III - EXPERT WORKING GROUP ON CUSTOMS PROCEDURES

Chairperson: Snežana Karanović, Assistant to the Minister, Ministry of Finance

1. With regard to the reduction of time required for **issuing of binding tariff information on classification of goods (BTI)**, and bearing in mind that complete request and enclosed complete manufacturers' documentations are of substantial significance for the reduction of time required for BTIs issuing, the request form for BTIs issuing has been made available on the website of the Customs Administration/Services/Binding

Decisions, with an explanation and guidelines relating to the documentation that needs to be enclosed when submitting request. Database of the issued valid BTIs has also been made available for viewing on the same website.

- 2. The Customs Administration, in cooperation with the World Bank, has developed and implemented an E-ORIGIN IT Application and the accompanying **database**, starting from June 1, 2019, which is intended to facilitate communication with the business community. In this connection, the following has been enabled:
- **E-OOP:** Electronic submission, amendment and reviewing of requests for issuing of binding decisions on origin of goods OOP, in accordance with Article 23 of the Customs Law, and
- **E-APPLICATION**: Electronic submission of applications for verification of knowledge of origin of goods within the procedure for acquiring the status of an Approved Exporter in accordance with the implementation of free trade agreements that envisage that.

Submission of requests and applications has been made available to all users, irrespective of their locations, and no specific hardware or installation process are required for the use of this IT Application. A standard web browser, preferably Google Chrome, is all that the users need. The IT Application has been successfully used for about 6 months now, and almost all companies are using only the new form of electronic communication and they get information on the status of their administrative case and/or on the date of exam for verification of knowledge within a very short period of time.

The effect of the above described is complete fulfilment of the plan for **Reduction of time required for OOP issuing,** since the application submission procedure and further communication are now carried out by electronic means, and all the OOPs are kept in electronic form through the new application and are available at any given moment to the users, through the simple access to the web application. Additionally, the introduction of the electronic service E-origin has resulted in facilitation and expediting of the process for acquiring the Approved Exporter status.

- 3. The activity related to processing of **electronically submitted customs declarations and carrying out of risk analysis before the arrival of express consignments**, with the aim of expediting of the customs procedure (the pre arrival processing) has been implemented through the adoption of the Customs Administration Explanation on simplified procedure for express consignments on November 1, 2018, whereby the pre arrival processing is envisaged.
- 4. Concerning the promotion and training of private sector regarding the use of simplified customs procedures and the status of an authorized economic operator which relates to enabling the option within the Customs Service not to request the same data from the holder of the Authorized Economic Operator status(AEO), where such data has already been provided in a recent period; this has been made possible through the newly adopted Explanations of the Customs Administration for simplified import and export procedures, for importers and exporters, for customs representatives and in the simplified procedure with express consignments.

Concerning the promotion and training of the private sector for the use of simplified customs procedures and the AEO status, in the part of this activity relating to preparation for recognition of the AEO status within CEFTA and PR China, and bearing in mind the complexity of the harmonisation process, as well as the fact that in December 2019 the Law on Ratification of Agreement between the Government of the Republic of Serbia and Government of the Republic of North Macedonia on mutual recognition of approvals of Authorized Economic Operators (AEOS) for security and safety and the Decision of the Joint Committee of the CEFTA on establishing of validation procedure for mutual recognition of national AEOS programs were adopted, further work remains to be carried out on promotion and training of the private sector.

# IV – EXPERT WORKING GROUP ON COORDINATION OF TRADE FACILITATION ACTIVITIES IN THE FRAMEWORK OF INTERNATIONAL AND REGIONAL TRADE AGREEMENTS

**Chairperson: Tatjana Dinkić**, Secretary of the NTFB, Head of the Group, Ministry of Trade, Tourism and Telecommunications

The following concrete obligations were fulfilled in 2019:

- 1. In October 2019, the Memorandum of Mutual Cooperation of 9 departments relating to coordination and exchange of data on goods among border services on the national level and between the CEFTA Parties was delivered to the CEFTA Secretariat. This Memorandum was the precondition for establishing of the system for electronic exchange of information on the movements of goods in the Region.
- 2. One of the specific obligations from the Additional Protocol 5 to the CEFTA Agreement pertained to the obligations of the regional administrations to deliver the Single list of fees and charges relating to import and export. With the aim of fulfilling this obligation, a table form of the Single list of fees and charges has been prepared based on inputs provided by all competent institutions. On **December 3, 2019, the NTFB submitted the Single List to CEFTA Secretariat for the purpose of its publication in the CEFTA Transparency Pack.** Bearing in mind that the Single List includes comprehensive information on permits, decisions, certificates, consents and certifications, as well as reasons for collection of charges, duties and fees, the competent authority and information on the payment time and method, this document is a useful source of information for all interested parties, particularly for the private sector. Of all the CEFTA Parties, Serbia has been the only one to submit this list.
- 3. Coordination of activities on conclusion of programs of Mutual Recognition of the Status of Authorized Economic Operators in compliance with the CEFTA Additional Protocol 5 was successfully completed by the Customs Administration and the Ministry of Finance, and in the meeting of the CEFTA Joint Committee that took place in Tirana on December 18, 2019, the Decision on Mutual Recognition of AEOs was adopted. In the Special Meeting of the CEFTA Joint Committee on February 25, 2020 in Tivat, the Decision on Facilitation of Trade in Fruits and Vegetables No. 01/2020 was also adopted.
- 4. Concerning the mutual recognition of documents to be submitted during importation and exportation, further efforts are needed to fulfil this objective in the CEFTA region, and therefore it has also been included in the Action Plan for the following period. The absence of mutual recognition for documents on the CEFTA level has been partially overcome by signing bilateral agreements with individual partners from this region, such as with North Macedonia and Bosnia and Herzegovina.
- 5. With regard to the problem of barriers to freight transport at border crossing points with the EU, a number of meetings were organized, intensive cooperation with the Coordination Body for borders was achieved and a number of measures were taken. In addition to that, in the meeting of the Sub-Committee on Trade, Industry, Customs and Taxation that took place on October 16, 2019, our side highlighted the issue of long delaying of freight vehicles at the border crossing points with Hungary and Croatia. This issue was included in the operational conclusions from the Sub-Committee meeting, and in relation to this, in the beginning of November 2019, a letter was addressed to the competent Directorate General (DG) of the European Commission. Complete

relevant information on this issue, which had been highlighted both by the competent institutions and by the private sector, was presented in this letter, along with a proposed solution. On March 4, 2020 in Brussels, the NTFB Secretary drew attention of the DG NEAR and DG TRADE representatives to this issue again, and specifically explained the scope of this problem not only for Serbia, but for the entire region as well. Although several meetings were organized among different departments competent for this issue, both on the bilateral and on the regional levels, no significant progress has been made so far, and the situation has been additionally aggravated with the outbreak of COVID-19 pandemics. Due to this, activities on setting up of special "green lanes" on border crossings for keeping essential transport flows moving (for food, medicines, medical equipment) have been initiated towards the EU on the CEFTA level.

7. In 2019, activities continued on the study on Regulatory and Procedural Barriers to Trade in the Republic of Serbia which has been carried out by the United Nations Economic Commission for Europe (UNECE). Coordination of answers to questions from the UNECE Questionnaire relating to the field of quality infrastructure was completed and the completed questionnaire was forwarded to the UNECE Secretariat. According to the plan, following the processing of the answers provided by competent departments, the UNECE Secretariat should present the draft study in the beginning of May 2020; after that, in June 2020, complete study should be presented and published.

#### 2.2. Action Plans of Expert Working Groups for 2020-2021

In the fifth NTFB meeting that was organized on December 27, 2019, Action Plans for the following two years, i.e. for the period 2020-2021 were adopted. The new Action Plans were drawn up in close cooperation with the representatives of the business community. The format of the Action Plans was modified and improved, so that it now comprises of a tabular presentation of planned activities, measures, competent institutions, as well as of the results' indicators. **The complete presentation of the Action Plans for 2020-2021 is provided in Annex 1 to this Report.** 

#### 3. MEETINGS OF THE NATIONAL COORDINATION BODY

#### 3.1. Meetings of the National Coordination Body

The fourth meeting of the NTFB took place on July 2, 2019 in Belgrade, with the following agenda:

- 1) Report on activities conducted by the Expert Working Groups relating to the fulfilling of obligations comprised in Action Plans for 2018 and 2019 and future plans;
- 2) Cooperation with the Coordination Body for border crossings in the Republic of Serbia concerning the initiative of the Serbian Chamber of Commerce to provide conditions for faster flow of freight motor vehicles on border crossings with Croatia and Hungary;
- 3) Analysis of results achieved and of the remaining open issues relating to the removal of barriers in mutual trade with Bosnia and Herzegovina and Northern Macedonia current situation relating to conclusion of agreements which are being negotiated;
  - 4) Other issues.

The fifth NTFB meeting took place on December 27, 2019 in Belgrade, with the following agenda:

- 1. Report on activities conducted by the Expert Working Groups relating to the fulfilling of obligations comprised in the Action Plans for 2018 and 2019;
- 2. Defining the new Action Plans of the Expert Working Groups for 2020 and 2021;

- 3. Adoption of the amended Decision on Establishing the Expert Working Groups of the NTFB:
- 4. Other issues.

Detailed information relating to the above listed agenda items from both meetings were explained in detail and presented in the narrative part of this Report in point 2.1.

### 3.2. Meetings of the Expert Working Groups of the National Coordination Body

#### I Expert Working Group on Agriculture, Sanitary and Phytosanitary Measures

The third meeting of the Expert Working Group for Agriculture, Sanitary and Phytosanitary Measures took place on September 27, 2019 in Belgrade. The agenda of the meeting covered further activities on implementation of the NTFB Action Plan for 2018 and 2019. The Expert Working Group members who were present in the meeting participated in discussions relating to concrete activities that needed to be taken with the aim of fulfilling the obligations from the Action Plan.

#### II Expert Working Group on Technical Barriers to Trade and Equivalent Measures

The second meeting of the Expert Working Group on Technical Barriers to Trade and Equivalent Measures took place on December 17, 2019 in Belgrade, in the premises of the AmCham. The agenda for the meeting covered the analysis of the achievements made within the activities envisaged in the Action Plan for the Expert Working Group for 2018 and 2019, as well as defining the activities from the previously adopted plans that would be transferred to the new Action Plans (for 2020-2021) and those that would be specified as completely new priority activities.

#### **III Expert Working Group on Customs Procedures**

This Working Group carried out their activities within the framework of the seminars and meetings for the business community, which were primarily organized with regard to acquiring of the status of **Authorized Economic Operators** (AEO) and the improvement of the customs procedure for **express consignments.** 

### IV Expert Working Group on Coordination of Trade Facilitation Activities under International and Regional Trade Agreements

This Working Group carried out their activities through coordination by electronic mail and formal letters addressed to the competent institutions relating to various processes on the international level. This primarily implied filling out of questionnaires and providing answers to requests of the international organisations in the field of trade facilitation. Direct result of these activities came in the form of positive assessments of the progress made in Serbia in the field of trade facilitation, which were primarily presented in the Annual Report of the European Commission within Chapter 30 (External Relations), as well as in the UN and WB documents.

### 4.2. Other activities within the international organisations of the UN system, conferences and seminars

On June 10-13, 2019, a visit to Stockholm and to the Swedish National Board of Trade, the most important institution within the system of the Swedish trade facilitation committee (SWEPRO) was organized by the IDEAS Centre from Geneva that is providing support to Serbia in the accession process to the WTO. The main objective of this visit was to get acquainted with the Swedish trade facilitation system with a special focus on

the consultation process and on the inclusion process of private sector in implementation of this policy. The Serbian delegation comprised of the NTFB representatives from the following institutions: the Ministry of Trade, Tourism and Telecommunications, Ministry of Agriculture, Forestry and Water Management, Ministry of Economy and the Customs Administration, which are also the members of the Expert Working Groups within the NTFB.

A regional meeting was organized in Vienna on May 21-24, 2019, on trade facilitation and/or border services' performance measuring. The delegation of the Republic of Serbia comprised of the representatives of the Customs Administration, Veterinary Directorate and the Ministry of Trade, Tourism and Telecommunications, who presented the results of the competent RS institutions in this field.

The German Organisation for international cooperation (GIZ) and the International Trade Centre (ITC) organized a meeting in Belgrade on May 29, 2019 as a part of the Project "Support to Trade Facilitation in CEFTA Region". The meeting was organized to present the study on quality diagnostics and business processes' analysis in relation to the barriers to trade in regional value chains of the iron and steel, as well as in the vegetable sectors. The representatives of this Project presented the draft analysis, conclusions and recommendations for resolving identified barriers in regional trade, and the present NTFB members provided specific comments and suggestions to improve the final version of the report.

Participation in the UNECE Steering Committee organized on May 28-29, 2019 in Geneva was achieved. The agenda for this meeting included, among other items, presentation of the basic findings that would be included in the UNECE study for strengthening of the national capacities for trade facilitation and elimination of regulatory barriers to trade in Serbia, which is being prepared in cooperation with the Secretariat of the United Nations Economic Commission for Europe.

Organized by the Customs Administration, on June 25 2019, a workshop took place during which the new IT application and electronic services for the origin of goods intended for the business community were presented, which were developed with the support from the International Financial Corporation (IFC) of the World Bank Group. The new IT application enabled to submit a request or an application, to monitor the status of the administrative case and to access the documents issued at any given moment, by electronic means, without being physically present in the Customs Administration and with the minimum of documentation required,. This resulted in facilitated and expedited procedures in this segment of customs operations for the business community.

Under the auspices of the World Customs Organisation (WCO) on March 4-5, 2020 in Brussels, the joint meeting of the WCO Trade Facilitation Agreement Working Group<sup>2</sup> (FTA) and Capacity Building Committee<sup>3</sup> was organized. In addition to the representatives of the customs and border services of the member states, the meeting was attended by the representatives of the Ministries of Trade, international organisations, private sector and scientific community as well. Within the agenda items relating to the individual national experiences from the work of the national trade facilitation committees, the NTFB Secretary pointed out to the <u>progress made in Serbia in the previous year, which was recognized by both the UN and the World Bank.</u>

The structure of the NTFB web site which is available in two languages (in Serbian and in English) includes: the basic information on the NTFB, the legal framework, documents, meetings, Expert Working Groups, proposals and initiatives, regional cooperation, events and news, useful links and the contact page.

#### 6. PLANNED ACTIVITIES

In the following period, the work will focus on the fulfilment of obligations determined in the Action Plans for 2020 and 2021 for each individual expert working group. Special activities will be focused on the obligations arising from the implementation of the Additional Protocol 5 to CEFTA, and additional further activities have been planned in cooperation with donors and international organisations on implementation of WTO Trade Facilitation Agreement, as well as on fulfilment of other obligations undertaken within the regional and bilateral agreements.

COVID 19 pandemic will present a substantial challenge and uncertainty for successful realisation of the Action Plans in the following period, particularly if we bear in mind that movements of people have been completely restricted due to the spreading of this virus, and that movement of goods, which has already been burdened with additional checks and suspensions since the outbreak of the migrant crisis, has also been additionally made difficult, particularly on the border crossing points with the EU.

It is necessary to strengthen the capacity within the NTFB, bearing in mind in particular that this is an additional activity and engagement for all the members, chairpersons of the working groups, as well as the for the representatives of the Ministry of Trade, Tourism and Telecommunications who are carrying out the work of the NTFB Secretariat, in addition to their regular obligations and tasks.
